

Noble Hound Pet Boarding and Doggy Daycare Policies and Release of Liability

THIS AGREEMENT is entered into by and between Noble Hound Pet Resort and pet owner (Owner) _____

Pet(s) name / breed(s) _____

1) I (Owner) represent that I am the legal owner of the above-named pet(s) and I assume all risks, dangers, and responsibility for injuries to the named pet(s). Owner understands and agrees that Owner is solely responsible for any harm while Owner's pet(s) is/are attending Daycare / Boarding.

2) PHOTO AND VIDEO RELEASE: We love to post pictures and videos on Facebook, our website, and/or in magazine ads. Owner agrees to allow Noble Hound to use Owner's pet's name and any images or likeness of Owner's pet taken while he/she is at Noble Hound, in any form, for use at any time, in any media, marketing, advertising, illustration, trade or promotional materials without compensation, and Owner releases to Noble Hound all rights that Owner may possess or claim to such image, likeness, recording, etc.

3) PET'S HEALTH: Owner further understands and agrees that Owner's pet(s) are healthy while attending Noble Hound Pet Resort have current vaccinations for rabies, distemper and Bordetella (dogs) . Owner is not enrolling any pet that has any condition that could potentially jeopardize the health of other pets or people and has not had any potentially communicable condition within 30 days prior to enrollment. Owner further understands that even if Owner(s) dog is vaccinated for Bordetella (Kennel Cough) there is a chance that the Owner's dog can still contract Kennel Cough. Owner agrees that Owner will not hold Noble Hound responsible if Owner's dog(s) contracts Kennel Cough or other dog-dog transmitted ailments.

4) FLEA/TICK FREE: All pets must be flea/tick free. Should a pet be observed to have fleas or ticks, a flea/tick bath treatment will be applied and charged to the owner at a rate of up to \$80.00 depending on severity and size of pet.

5) GROUP PLAY: All dogs must pass a general behavior assessment in order to attend dog-dog group play. No dog may be admitted to group play who shows any signs of any type of aggression. Owner further understands and agrees that in admitting Owner's dog(s) to dog-dog group play, Owner is representing to Noble Hound that Owner's dog(s) is/are in good health and have not harmed, shown aggression, or exhibited any threatening behavior towards any person or other dogs. Any dog demonstrating aggression or other behavior deemed unacceptable by Noble Hound staff may be required to leave daycare/boarding.

6) RELEASE OF LIABILITY: Owner understands and agrees that during normal pet play, Owner's pet may sustain injuries. Pet play is monitored by Noble Hound staff to best avoid injury, but scratches, punctures, torn ligaments, and other injuries may occur despite the best supervision. Owner further understands and agrees that neither daycare/boarding nor any of its employees, staff, or volunteers will be liable for any illness, injury, death, and/or escape of Owner's pet(s) provided that reasonable care and precautions are followed, and Owner hereby releases Noble Hound staff or volunteers of any liability of any kind whatsoever arising from or as a result of Owner's pet(s) attending Noble Hound Pet Resort.

7) PERSONAL PROPERTY: Owner understands that Owner is solely responsible for any harm, including to any other pet(s), to the employees or invitees of Noble Hound or to the equipment, facilities, or other property of Noble Hound, caused by Owners pet(s). Owner also agrees that Noble Hound shall not be responsible or liable for any lost or damaged personal property belonging either to Owner or Owner's pet.

8) FOOD/MEDS when boarding overnight, Owner agrees that it is the Owner's responsibility to leave adequate supply of food and medications for Owner's pet(s) during the entire time Owner's pet is cared for by Noble Hound. Should the food/medication supply need replacement, Owner authorizes Noble Hound to replace and charge meds and food costs to your account.

9) VETERINARIAN LIABILITY AND CARE: Owner agrees to Noble Hound to obtain medical treatment for Owner's pet(s) if he/she appears ill, injured, or exhibits any other behavior that would reasonably suggest that pet(s) may need medical treatment including anesthesia. Owner agrees to be fully responsible for the cost of any such medical treatment and for the cost of any transportation for the purposes of such treatment. Owner gives permission to Noble Hound to use, our Noble Hound Animal Hospital, Owner's vet or nearest 24-hour vet hospital for required treatment. Yes _____ or No _____

10) WEAKENED IMMUNE SYSTEM: Owner understands special-needs dog/ kittens, young puppies/ kittens, and senior pets naturally have a higher risk of injury, stress-related illnesses, weakened immune system, or exacerbation of any pre-existing condition. As such, by using our facility for daycare or boarding the Owner is waiving any claim for injury or illness experienced by Owner's pet while in our care.

11) ELDERLY PETS: Owners of elderly pets (approaching the end of life) need to know if in the event Owner's pet passes on while in our care, our policy is to keep your pet with the Noble Hound Animal Hospital, where he/she will be held until Owner can be reached by the Vet for further instructions.

12) GROOMING expense to be paid if Owner's pet(s) nails are too long and causing breaking of skin or deep scratches to staff, volunteers, and/or other pets. Nail trim cost up to \$15.00. In addition if Owner's pet(s) happens to soil their fur we will bathe them at Owner's expense.

13) PREPAID PACKAGES: Owner understands that prepaid daycare packages are nonrefundable and expire 12 months from date of purchase. Discounted packages are provided only if they are paid for in advance.

14) PAYMENTS are due and payable at the end of each visit. Payment may be made in American currency, Visa, Discover, or Master Card. \$25 NSF charge for returned checks. . We do not keep credit

card information on file. There is a 5% extra processing charge when credit cards are taken over the phone and cards are not swiped in person.

15) CANCELLATION / NO-SHOW POLICY: Cancellations must be done 48-hours prior to reservation date. If cancellation notice is less than 48-hours an amount of two nights stay will be invoiced.

16) CLOSING TIME: Owner agrees that if Owner's pet(s) is/are not picked up by closing time of 6:30 p.m. Wisconsin time, then Owner hereby authorizes overnight boarding appropriate for pet(s) and to pay Noble Hound Animal Hospital and Pet Resort for applicable overnight boarding charge plus any charge for required food and meds.

17) RIGHT OF REFUSAL: Noble Hound reserves the right to refuse admittance to any pet or dismiss any pet that does not meet or maintain the health, temperament or other daycare/boarding standards. The determination shall be made at the sole discretion of Noble Hound.

18) ABANDONMENT: If Pet(s) is/are not picked up by Owner (or an Authorized Representative of Owner) within fourteen (14) days after the Pet(s) is/are scheduled for check-out, Owner understands that Pet(s) shall be considered abandoned and Noble Hound has the legal right to place Pet(s) with a new owner or turn Pet(s) over to a rescue.

19) FULL FORCE AND EFFECT: Owner further understands and expressly agrees that each and every of the foregoing provisions contained in paragraphs 1-18 shall be in force and effect and shall apply to each and every occasion on which Owner's pet(s) stays with Noble Hound for daycare, extended boarding, or other services. This Agreement shall remain in full force and effect as between the parties until and unless otherwise cancelled or superseded by a writing signed by the parties. Owner hereby certifies that Owner has read and understands this Waiver and Release of Liability and the regulations set forth above. By signing this agreement, Owner agrees to be bound by its terms and conditions.
